

AGREEMENT

between

International Center for Research and Postgraduate Training in Mathematics

Institute of Mathematics, Vietnam Academy of Science and Technology

University of Science and Technology of Hanoi, Vietnam Academy of Science and Technology

Centre International de Mathématiques Pures et Appliquées (CIMPA), International Center for Research and Postgraduate Training in Mathematics (ICRTM), the Institute of Mathematics, Vietnam Academy of Science and Technology (IM, VAST) and University of Science and Technology of Hanoi, Vietnam Academy of Science and Technology (USTH, VAST) agree to the following agreements with the objective of promoting and developing their mutual cooperation and mutual exchanges. Both institutions will comply with the respective national laws of the two countries along with international treaties/agreements on the basis of functions, duties and competencies of both parties.

1. Purpose

CIMPA and ICRTM jointly cooperate to support the following research and training program in mathematics at Vietnam:

- (1) Thematic semester in mathematics at ICRTM;
- (2) Training program in Applied Mathematics at USTH, VAST jointly implemented with IM, VAST.

2. Support

2.1. Thematic semester in mathematics at ICRTM:

CIMPA and ICRTM collaborate to support the participation costs of up to two young researchers (under 36 years of age or with a thesis obtained in the last 5 years) based in developing countries (as defined by the IMU-CDC). The laureates will participate to the full event. CIMPA will pay for the travel costs to Hanoi (up to a maximum amount of 500 euros per laureate including visa fees) and a per diem of 300 euros per month. ICRTM will take care and pay for the accommodation.

The planning for the calls and selections are defined jointly by the two institutions to allow sufficient time for the visa applications. In particular, ICRTM will communicate the information (topic, dates, contact details of the organizers, poster) at the earliest and at least 6 months before the start of the program. CIMPA will inform the organizers of the specificities of this action and will help them in the selection process.

2.2. Training program in Applied Mathematics at USTH, VAST jointly implemented with IM, VAST:

CIMPA will provide up to 2,000€ per year and ICRTM will provide up to 50.000.000 Vietnam Dong per year to support the travel, the accommodation and meals of at least three instructors. Each instructor is expected to give at least 18 hours of pedagogical activities (lectures, tutorials, programming sessions) of a course of the training program. Reimbursement of the expenses will be made on presentation of the invoices by a local contact person who will send the documents to CIMPA. There is no honorarium for the lecturers.

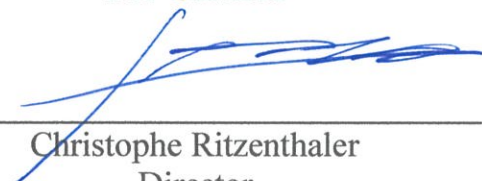
2.3. Any disagreement that may arise from the interpretation or application of this MOU will be resolved by consultations or negotiations between the parties.

3. Duration and Termination

This agreement is of unlimited duration. It may be amended after discussion between the two parties and unilaterally terminated by any of the parties after resolution of current cases.

4. This agreement will be drawn up in English in four copies, with one copy for each institution. Either copy is of equal validity.
